- Support Finance teams based in other UK sites through the year end processes
- Draft, redraft communication and manage the implementation of accounting policies within the new Group's Financial Reporting Manual, procedures and controls to obtain the highest integrity of financial reporting
- Responsible for the monthly management accounts and budget for the Head Office
- Assist the Group Financial Controller in taxation and audit matters
- Prepare external reports for other governmental agencies such as the ONS surveys
