

## **Credit Controller**

We have an exciting opportunity for a Credit Controller to join us. As Credit Controller, you will work within a team of credit controllers. This role is at the heart of servicing over 6,000 customers with the responsibility of processing a large number of transactions across the different stock lines of our Brands as well as for many of the Company's prime accounts, which involve complex Excel formulation.

## Responsibilities

- Manage complex high volume self-billing reconciliations through Excel analysis, using pivot and lookup tables to devise and develop the processes as necessary
- Manage and record accurate stock levels through the self-billing process / Excel
- Accurately record and enter currency and sterling cash received either by cheque or direct Bank transfer
- Resolve customer's queries by recording disputed items through the Mertex system and following up with relevant departments to ensure resolutions are efficiently resolved
- Maintain a clean ledger and have a proactive approach to ensure that all issues that alter this status, are dealt with
- Actively chase for payment on all overdue items by email, telephone, letter or legal
- Maintain notes on Mertex system of all customer communication so that others looking at an account can understand why and when a customer is overdue
- Review order held reports and release only on payment received or justifiable credit
  analysis. Calls to all customer held orders must be made so the customer is aware of a
  delay in delivery and have a chance to resolve the matter
- Distribute statements and Dunnings letters on a timely basis and in accordance with company credit policy
- Review and recommend credit limits both at application stage and on an ongoing basis
- Raise journals and credit notes where necessary
- Cover all areas of the credit control department as and when required
