

## **Group Reporting Manager.**

### **Responsibilities.**

- Preparation of monthly/half yearly/annual consolidation including internal reporting documents (e.g. Group management accounts).
- Responsible for external Plc reporting at half year and year end.
- Responsible for both Group and subsidiary statutory accounts, including liaising with the auditors.
- Act as the principle point of contact for the auditors on Group and technical matters.
- Management of reporting templates to capture business unit submissions and setting the timetable for submission, including holding teams to account.
- Responsible for providing technical accounting advice and owning Group policies, including ensuring that these are followed by business units.
- Documenting accounting policies and procedures, including preparing papers for audit purposes.
- Managing Group cash flow including forecasting cash positions (both short and longer term) and monitoring business unit cash needs. Comparing actual cash flow to forecast and completing variance analysis.
- Manage the control and accounting of the Group pension and employee-related benefits including share schemes.
- Develop and review the Group's financial control framework and ensure compliance by business units.



- Support on projects on an ad-hoc basis such as M&S, business integration and process improvement.

- Delivery of the monthly management accounts, statutory accounts and reporting to group to agreed deadlines.
- Accuracy of monthly management accounts and across all work areas.
- Clearly documented policies and procedures.

- Business unit Finance teams – Setting timetables and ensuring information received on time.
