- Capable of stepping into the Proof press printer role if required.
- Careful preparation of new Cylinders/Rollers prior to proofing.
- To carry out quick changeovers between jobs.
- · Carry out the cleaning of ancillary equipment when required.

- Attend/support maintenance meetings as per the schedule.
